## ABLE Account Applications by State

An ABLE Account is a tax-advantaged savings and investment account for individuals with disabilities. Most importantly, it allows these individuals to save money for disability-related costs such as housing, education, and healthcare, without jeopardizing their eligibility for government benefits like SSI and Medicaid.

Regardless of where you reside, you can open an ABLE account in any state that accepts out-of-state residents. To compare programs across different states, you can select up to three programs by using the [National ABLE State Comparison Tool, click here.](#)
