

Future Care Planning Series: Importance of Powers of Attorney for Parents and Caregivers

Power of Attorney Forms by State

Power of Attorney (POA) is a legal document that allows you to designate individuals to make medical and financial decisions on your behalf should you become unable to make them yourself.

There are two types of Power of Attorney:

- **Healthcare POA:** Also known as Healthcare Proxy or Medical Power of Attorney, this document designates a trusted individual (often called the 'Agent') to make medical decisions on your behalf if you become incapacitated or unable to communicate.
- **Property POA:** This document designates a trusted individual (often called the 'Agent') to manage your financial affairs and assets on your behalf if you become incapacitated or unable to communicate.
